Notes on Application for S1 Discretionary Places

1. Application forms can be obtained from the school reception desk from 1 December 2025 or downloaded from school's homepage **【<http://www.twghwfns.edu.hk>】**
2. The completed application form must be returned to the School Office **IN PERSON or apply via the SSPA e-Platform (for parents who have registered as SSPA e-Platform users with “iAmSmart+) from 2 January to 16 January 2026.** Please refer to the notes below.
3. For environmental reason, **please DON'T submit your application documents in clear files / folders.** All data collected are used for application purpose only and will be destroyed afterwards. **(Recommendation letter from primary school is NOT required.)**
4. Number of discretionary places for admission to Secondary One in September 2026 is 50.
5. Applicants should only apply for S1 places in **a MAXIMUM OF TWO Secondary Schools** participating in the SSPA system. Otherwise, their application will be disregarded.
6. All applicants will be invited to attend an interview on 7 March 2026. The related arrangements will be announced later.
7. The School will notify parents of successful DP applicants by letter and phone on 31 March 2026. The results of SSPA will be released by the Education Bureau on 7 July 2026. Applicants NEED NOT contact our school for information.
8. Parents should not offer any benefit to the school staff or school management committee members in connection with their applications.
9. The personal information submitted by the applicant will be used in the selection procedure of S1 discretionary places. It may be transferred to the government departments concerned for allocation of S1 places if necessary.
10. According to the Personal Data (Privacy) Ordinance, applicants have the right to amend or inquire about the personal information that he/she submitted. Applicants should submit a letter of request if necessary.
11. The applicant is responsible for providing correct and up-to-date information to the school. In case of any changes to the information in the application forms, the applicant must contact the school as soon as possible.
