Types of Appeal:

- ① **Remarking**
- ② **Rechecking for Technical Errors**

- * Candidates may apply for remarking and/or rechecking for **up to a total of 4 subjects**.
- * For **Chinese Language** and **English Language**, applications for **remarking** may be made on a subject or component basis. For applications on a component basis, the other components of that subject will also be **rechecked** for technical errors but **not remarked**.
- * An application for one or more components of a subject is counted as one subject.
- * For **Mathematics**, candidates may apply for remarking either the Compulsory Part or Extended Part, or both (if applicable), as a single subject.
- * For all **other subjects**, applications are processed on a subject basis only.
- * Remarking is **NOT** available to School-based Assessment components, multiple-choice papers/sections and practical papers of subjects.

Application Procedures:

- * Applications should be submitted through the school. Each candidate can **only** submit **one application**. Online amendment will **NOT** be allowed after submission.
- * Upon successful submission of applications, candidates will immediately receive an acknowledgement with the Demand Note via their registered email address and an SMS notification.

- * Please bring along with the Demand Note to any 7-Eleven or Circle-K Convenience Store in Hong Kong and settle the payment **within 2 calendar days** upon online submission via school.
- * Should candidates fail to pay by the deadline, a late payment fee of **\$ 295** will be charged. Candidates must settle the application fee and the late payment fee at the HKEAA Southorn Centre office (12/F, Southorn Centre, 130 Hennessy Road, Wan Chai) **by 5:30 pm, 25 July 2024 (Thu)**.
